The Fujitsu fi-6400/fi-6800 Free Consumables Promotion ("The Promotion") is available to end user customers, aged 18 and over, located in Austria, Belgium, Denmark, Estonia, Finland, France, Germany, Hungary, Italy, Latvia, Lithuania, Luxembourg, Netherlands, Norway, Republic of Ireland, Saudi Arabia, Sweden, Switzerland, United Arab Emirates and United Kingdom; and does not apply where the product will be resold.
2. The Promotion is only valid on the purchase of new Fujitsu fi-6400 and Fujitsu fi-6800 Series scanners purchased between 15th December 2017 and 31st March 2018 inclusive. The last claim date is 30th April 2018.
3. The Promotion is only valid for new Fujitsu fi-6400 and Fujitsu fi-6800 Series scanners purchased and invoiced directly from a qualifying Fujitsu Scanner Partner or Retailer in Austria, Belgium, Denmark, Estonia, Finland, France, Germany, Hungary, Italy, Latvia, Lithuania, Luxembourg, Netherlands, Norway, Republic of Ireland, Saudi Arabia, Sweden, Switzerland, United Arab Emirates and United Kingdom. Fujitsu is not responsible or liable for any additional consumables or spare parts that the Customer may need to purchase due to a higher annual scanning volume, increased scanner daily utilization or misuse.
